

**TOWN OF PARACHUTE, COLORADO
RESOLUTION NO. 2018-22**

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO, SITTING AS THE PARACHUTE LIQUOR LICENSING AUTHORITY, APPROVING THE APPLICATION OF GRAND RIVER HOTEL, INC., FOR A BEER AND WINE LICENSE FOR THE PREMISES LOCATED AT 221 GRAND VALLEY WAY.

WHEREAS, the Town of Parachute (“Parachute” or the “Town”) is a home-rule municipality organized pursuant to the Colorado Constitution and with the authority of the Parachute Home Rule Charter; and

WHEREAS, pursuant to Title 12, Articles 46 and 47 of the Colorado Revised Statutes, the Town is authorized to administer and regulate the sale of alcoholic beverages within the Town; and

WHEREAS, the Town has adopted procedures for the licensing of retail vendors of alcohol under Chapter 6.12 of the Parachute Municipal Code; and

WHEREAS, the Grand River Hotel, located at 221 Grand Valley Way in Parachute, Colorado, has applied for a Beer & Wine on-premises liquor license pursuant to C.R.S. § 12-47-409; and

WHEREAS, the Parachute Board of Trustees, sitting as the Liquor Licensing Authority, desires to enter its written findings and decisions regarding the approval of the Grand River Hotel’s liquor license by resolution pursuant to the authority granted under the laws of the State of Colorado and Town of Parachute.

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. Based upon the testimony heard and evidence presented at a public hearing held on April 19, 2018, the Authority finds as follows:

- A. That Grand River Hotel has submitted a complete application for an on-premises Beer & Wine license on forms maintained by the Town.
- B. That Grand River Hotel has submitted a complete liquor license application to the State of Colorado.
- C. That no prohibitions contained in Sections 12-46-104 or 12-47-313, C.R.S., apply to Grand River Hotel.
- D. That there are no liquor licenses of the same class located within the Town of Parachute and one mile of the proposed location, and that it is the desire of the adult inhabitants of the neighborhood that the license be granted.

- E. That public notice requirements have been met.
- F. That the applicant is of good moral character, record, and reputation and has possession of the premises, suitable for the requested license.

Section 3. The application of Grand River Hotel, Inc., for a Beer & Wine liquor license at 221 Grand Valley Way in the Town of Parachute, Colorado is hereby approved and the license is ordered to be issued to the applicant subject to e approval of the State of Colorado Liquor Enforcement Division.

Section 4. The Town Clerk is hereby directed to send to the applicant a copy of the within resolution by certified mail, return receipt requested, approving the issuance of said license at the address shown on said application.
