**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO, CANCELLING THE REGULAR MUNICIPAL ELECTION ON APRIL 7, 2020 BECAUSE NO COUNCIL MEMBER POSITION IS CONTESTED, AND DECLARING THE CANDIDATES ELECTED.**

**WHEREAS**, the Town of Parachute is scheduled to hold a regular municipal election on April 7, 2020;

**WHEREAS**, four Council member positions on the Town Council, one of which is to fill a vacancy, are to be considered at the regular municipal election;

**WHEREAS**, no Councilmember position or office is contested or opposed, and one candidate desires to fill the vacant position on Council for the remaining 2 years of the term;

**WHEREAS**, pursuant to the Colorado Municipal Election Code, C.R.S. § 31-10-101 *et seq.*, the Town Council has adopted Chapter 3.10 of the Parachute Municipal Code, authorizing the Town to cancel unopposed municipal elections and declare candidates elected; and

**WHEREAS**, pursuant to the Colorado Municipal Election Code and Town Code, and the interest of fiscal responsibility, the Town Council desires to cancel the municipal election scheduled for April 7, 2020, and declare the unopposed candidates for office elected.

**NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO:**

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. Pursuant to the Colorado Municipal Election Code and Chapter 3.10 of the Municipal Code, the Regular Municipal Election previously scheduled for April 7, 2020, is hereby CANCELLED.

Section 3. The following candidates for municipal office are hereby deemed and declared elected:


as Councilmember, Leah Frink;  
as Councilmember, Claudia Flores Cruz;  
as Councilmember, Fred Andersen;  
as Councilmember, Artemio Baltazar.

Mr. Baltazar shall fill the Councilmember position vacated earlier this year and shall serve out the remaining portion of that term (expires 2022).


