RESOLUTION NO. 2020-32**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO, ALLOCATING GENERAL FUNDS TO LOCAL NONPROFIT ORGANIZATION(S) IN RESPONSE TO COVID-19 PUBLIC HEALTH EMERGENCY, AND AUTHORIZING THE EXPENDITURE OF FUNDS IN SUPPORT THEREOF

WHEREAS, the Governor of the State of Colorado declared a statewide emergency regarding the occurrence or imminent threat of widespread or severe damage, injury or loss of life or property resulting from the 2019 Novel Coronavirus (“COVID-19”) on March 10, 2020; and

WHEREAS, by Resolution No. 2020-14, the Town Council of the Town of Parachute declared a local disaster emergency related to COVID-19 on March 19, 2020;

WHEREAS, COVID-19 has been confirmed to exist in Garfield County and the Town;

WHEREAS, COVID-19 has caused a devastating impact on the Town residents;

WHEREAS, the Town Council is empowered by C.R.S. § 3-15-410(1)(b) to take all actions and make all regulations that may be necessary or expedient for the promotion of health or the suppression of disease;

WHEREAS, to aid individuals affected by the economic impacts of COVID-19 and the related public health orders, the Town wishes to allocate general funds to local nonprofit organizations to provide grant funding to qualified residents;

WHEREAS, the Town Council wishes to allocate up to \$20,000 from the General Fund to the local nonprofits; and

WHEREAS, the Town Council finds and determines that the adoption of this Resolution is in the interests of the public life, healthy, and safety of the Town and its residents, and is authorized by applicable law.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO:

Section 1. Recitals. The foregoing recitals are hereby incorporated as findings of the Town Council.

Section 2. Allocation of funds to local nonprofits.


- A. The Town Council hereby allocates up to \$20,000 from general funds to local nonprofits to provide funding to Parachute residents affected by the COVID-19 pandemic and related public health orders.

B. The Town Manager, and all other officers, employees, and agents of the Town shall take all action necessary or reasonably required to allocate the general funds to the local nonprofits. All actions heretofore taken by the Town Manager, and the other officers, employees, and agents of the Town in connection with the administration of the funds are hereby ratified, approved, and confirmed in all respects.

INTRODUCED, PASSED, ADOPTED, AND APPROVED by a vote of 4 to 0 of the Town Council of the Town of Parachute, Colorado at a regular meeting held at Town Hall in the Town of Parachute, Colorado, on the 15th day of October 2020 and approved by the Mayor on the 15th day of October 2020.


