A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO, APPROVING AN AGREEMENT TO FUND AND PROVIDE A SCHOOL RESOURCE OFFICER IN PARTNERSHIP WITH GARFIELD COUNTY SCHOOL DISTRICT 16

WHEREAS, GARFIELD SCHOOL DISTRICT No. 16 ("District"), and the TOWN OF PARACHUTE wish to provide for a school resource officer (SRO) at Grand Valley High School and local school system;

WHEREAS, C.R.S. § 29-1-201, et seq. authorizes and encourages local governments to cooperate by contracting with one another for their mutual benefit;

WHEREAS, pursuant to Section 1-14 of the Home Rule Charter, the Town of Parachute (the "Town") is empowered to provide services to other governmental units pursuant to an intergovernmental agreement approved by resolution or ordinance;

WHEREAS, to provide for the safety, education, and protection of students at Grand Valley High School, the Town Council supports the SRO program and its continued existence in the District;

WHEREAS, the Town Council wishes to approve the Agreement and perform its obligations thereunder, and finds and determines that doing so is in the interest of the Town.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. Recitals. The foregoing recitals are incorporated herein as if set forth in full and are adopted as findings.

Section 2. Agreement. The Town Council hereby approves the SRO Agreement set forth in **Exhibit A** and authorizes the Mayor or Town Manager to sign the SRO Agreement. All actions heretofore taken by the Town Manager, and the other officers, employees, and agents of the Town in connection with the subject matter of this Resolution are hereby ratified, approved, and confirmed in all respects. Further, the Town Council authorizes and directs the Town Manager to take such steps as are necessary to implement this Resolution and the Agreement.
