**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO, APPROVING AND ADOPTING A TRAILS PLAN FOR THE TOWN OF PARACHUTE.**

**WHEREAS**, pursuant to C.R.S. § 31-23-206, it is the duty of the Town of Parachute Planning Commission to make and adopt a comprehensive master plan for the physical development of the municipality, including any areas outside of its boundaries;

**WHEREAS**, on May 11, 2023, the Planning Commission held a duly noticed public hearing to consider adoption of the Comprehensive Master Plan, at which the Planning Commission considered comments from Town staff and the public;

**WHEREAS**, on May 11, 2023, the Planning Commission approved Resolution No. **2023-01-PC**, approving and adopting in its entirety the Comprehensive Master Plan.

**WHEREAS**, the Town, through a team of consultants and participation by both the Planning Commission and Town Council, prepared and proposed the Town of Parachute 2023 Trails Master Plan (“Trails Plan”);

**WHEREAS**, on May 11, 2023, the Planning Commission held a duly noticed public hearing to consider adoption of the Trails Plan, at which the Planning Commission considered comments from Town staff and the public;

**WHEREAS**, the Town of Parachute Comprehensive Plan, as well as any legally adopted amendments, shall be considered a Master Plan for the purposes of Section 1-15 of the Town Charter.

**WHEREAS**, the Town Council desires to also adopt the Trails Plan approved and adopted by the Planning Commission.

**NOW, THEREFORE, BE IT RESOLVED, BY THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO THAT:**

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. Pursuant to Section 1-15 of the Town Charter, the Town Council hereby approves and adopts in its entirety the Trails Plan, attached hereto as **Exhibit A** and incorporated herein by this reference, as the official master trails plan for the Town of Parachute.

Section 3. A copy of the Trails Plan is available for viewing during normal business hours at Town Hall and will be posted on the Town’s website.

Section 4. The Town Manager shall have the authority to make non-substantive revisions to the Trails Plan such as correcting grammatical and typographical errors and updating hyperlinks in the Plan without approval of the Planning Commission or Town Council.
