RESOLUTION NO. 2023-23

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO, ACTING AS THE LOCAL LIQUOR LICENSING AUTHORITY, APPROVING THE APPLICATION OF FAMILY DOLLAR STORES OF CO. LLC, FOR A FERMENTED MALT BEVERAGE LIQUOR LICENSE FOR THE PREMISES LOCATED AT 98 CARDINAL VALLEY WAY.

WHEREAS, the Town of Parachute (“Parachute” or the “Town”) is a home-rule municipality organized pursuant to the Colorado Constitution and with the authority of the Parachute Home Rule Charter; and

WHEREAS, pursuant to Title 44, Article 3 of the Colorado Revised Statutes, the Town is authorized to administer and regulate the sale of alcoholic beverages within the Town; and

WHEREAS, the Town has adopted procedures for the licensing of retail vendors of alcohol under Chapter 6.12 of the Parachute Municipal Code; and

WHEREAS, the Family Dollar Stores of Colorado, LLC, dba Family Dollar #26890 (“Family Dollar”), located at 98 Cardinal Way in Parachute, Colorado, has applied for a Fermented Malt Beverage liquor license pursuant to C.R.S. § 44-3-301; and

WHEREAS, the Parachute Town Council, sitting as the Liquor Licensing Authority, desires to enter its written findings and decisions regarding the approval of the Family Dollar’s liquor license by resolution pursuant to the authority granted under the laws of the State of Colorado and Town of Parachute.

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. Based upon the testimony heard and evidence presented at a public hearing held on August 17, 2023, the Authority finds as follows:

- A. That Family Dollar has submitted a complete application for a Fermented Malt Beverage license on forms maintained by the State.
- B. That Family Dollar has submitted a complete liquor license application to the State of Colorado.
- C. That no prohibitions contained in Section 44-3-301, C.R.S., apply to Family Dollar.
- D. That there are no liquor licenses of the same class located within one mile of the proposed location, and that it is the desire of the adult inhabitants of the neighborhood that the license be granted.
- E. That public notice requirements have been met.
- F. That the applicant is of good moral character, record, and reputation and has possession of the premises, suitable for the requested license.

Section 3. The application of Family Dollar Stores of Colorado, LLC, for a Fermented Malt Beverage liquor license at 98 Cardinal Way in the Town of Parachute, Colorado is hereby approved, and

the license is ordered to be issued to the applicant subject to the approval of the State of Colorado Liquor Enforcement Division.




