

**TOWN OF PARACHUTE
ORDINANCE NO. 715-2017**

AN ORDINANCE OF THE TOWN OF PARACHUTE, COLORADO, AMENDING CERTAIN SECTIONS OF THE PARACHUTE MUNICIPAL CODE TO ESTABLISH A NEW APPENDIX CONTAINING FEES APPLICABLE UNDER THE CODE.

WHEREAS, the Town of Parachute (“Parachute” or the “Town”) is a home-rule municipality organized under Article XX of the Colorado Constitution and with the authority of the Parachute Home Rule Charter; and

WHEREAS, the Parachute Municipal Code incorporates fees and fines subject to change by resolution of the Town Board of Trustees; and

WHEREAS, the Board of Trustees finds and believes that the creation of an appendix to the Town Code to set forth the fees and fines applicable thereunder would allow for increased clarity and compliance with the Town’s ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. Recitals. The foregoing recitals are incorporated herein as if set forth in full.



Section 3. Appendix Creation. The Parachute Municipal Code is hereby amended by the addition of a new Appendix A, as provided on the attached **Exhibit B**.



Public notice is hereby given that an Ordinance entitled:


