

**TOWN OF PARACHUTE
ORDINANCE NO. 720-2017**

AN ORDINANCE OF THE TOWN OF PARACHUTE, COLORADO, APPROVING A LEASE WITH OPTION TO PURCHASE REAL ESTATE WITH T&T AND ASSOCIATES AND TO AUTHORIZE THE LEASE AND ACQUISITION OF REAL PROPERTY

WHEREAS, T & T and Associates, a Colorado limited partnership (“T&T”) owns certain property located within the Town of Parachute identified as Garfield County Parcel No. 2407-072-00-023 (the “T&T Property”);

WHEREAS, the Town of Parachute (the “Town”) wishes to lease with an option to purchase 2 acres of the T&T Property (the “Second 2-Acre Parcel”) for future public use as a Town recreational amenity, and T&T wishes to lease and sell the same;

WHEREAS, accordingly, the Town and T&T have negotiated the Lease with Option to Purchase attached hereto as **Exhibit A** (“Lease Option”), which identifies the property, lease terms, purchase price, and other terms of sale;

WHEREAS, Section 1-18 of the Town Charter states that “[t]he Board [of Trustees], by ordinance, may purchase, sell, exchange, receive by donation, and enter into a lease, or dispose of any interest in real property or water rights, including easements.”;

WHEREAS, further, Section 13-11 of the Town Charter states that “[t]he Town shall have the power to acquire, own, sell, lease, exchange, dispose of, or otherwise deal with real or personal property by ordinance without the need for an election.”;

WHEREAS, the Board of Trustees believes it is in the best interests of the Town to acquire the Second 2-Acre Parcel and advances a legitimate government interest; and

WHEREAS, the Board of Trustees wishes to approve the Real Estate Contract, authorize the acquisition of the Second 2-Acre Parcel, authorize the Town Manager to make any amendments to the Lease Option other than the purchase price and take other acts reasonably necessary to acquire the Second 2-Acre Parcel, and authorize the Town Manager or Mayor to execute any documents to effectuate such conveyance, including a deed.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. The Board of Trustees hereby approves the Lease Option in substantially the same form as that enclosed as **Exhibit A** and incorporated herein by this reference, and authorizes the Town Manager to make any amendments to the Lease Option that are reasonably necessary for the acquisition of the Second 2-Acre Parcel, other than amendments to the purchase price, without

further approval of the Board of Trustees.

Section 3. The Board of Trustees hereby authorizes the Town Manager or Mayor to take all actions pursuant to the Lease Option, to sign all documents necessary to effectuate the lease and acquisition of the Second 2-Acre Parcel, including a deed and any documents required by a title company, and to take other actions related to this transaction.

Section 4. If any provision of this Ordinance is found to be unconstitutional or unlawful, such finding shall only invalidate that part of portion found to violate the law. All other provisions shall be deemed severable and shall continue in full force and effect.

Public notice is hereby given that an Ordinance entitled:


