

**TOWN OF PARACHUTE
ORDINANCE NO. 735-2017**

AN ORDINANCE OF THE TOWN OF PARACHUTE, COLORADO, AMENDING SECTION 15.02.230 OF THE MUNICIPAL CODE TO INCLUDE OFF-PREMISES STORAGE FACILITIES AND MARIJUANA TRANSPORTERS AS NEW CLASSES OF USES AUTHORIZED IN CERTAIN ZONE DISTRICTS.

WHEREAS, the Town of Parachute (“Parachute” or the “Town” is a home-rule municipality organized under Article XX of the Colorado Constitution and with the authority of the Parachute Home Rule Charter; and

WHEREAS, by Article XVIII, Sections 14 and 16 of the Colorado Constitution, the voters of the State authorized the possession and use of marijuana for medical and retail/recreational purposes; and

WHEREAS, the Colorado Marijuana Enforcement Division authorizes the licensing of marijuana transporters and off-premises storage facilities for marijuana license holders; and

WHEREAS, the Town has exercised its right of local control in setting forth a system for the permitting, regulation, and zoning of medical and retail marijuana businesses in the Town; and

WHEREAS, the Parachute Board of Trustees finds and declares that it is in the interest of the public health, safety, and welfare to identify appropriate zoning restrictions for the location of off-premises storage facilities in the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. The Town of Parachute Board of Trustees hereby amends Section 15.02.230 of the Parachute Municipal Code to include the off-premises storage facilities as commercial/retail uses, consistent with the following:


