**ODINANCE NO. 756-2018**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, AMENDING THE PARACHUTE MUNICIPAL CODE TO UPDATE REFERENCES TO RELOCATED STATE STATUTES**

**WHEREAS**, the Colorado General Assembly enacted S.B. 16-163 directing the Colorado Office of Legislative Legal Services (“OLLS”) to conduct a study of an organizational recodification of Title 12 of the Colorado Revised Statutes (“C.R.S.”) governing the regulation of professions and occupations; and

**WHEREAS**, OLLS prepared and the General Assembly has enacted 26 separate bills, including HB-1025 (liquor) and HB18-1023 (marijuana) (the “Title 12 Reorganization Bills”) to reorganize and relocate various provisions of Title 12 to a newly created Title 44 of the C.R.S. entitled Revenue – Regulation of Activities; and

**WHEREAS**, the Parachute Municipal Code includes various references to Title 12, C.R.S., including the liquor, beer, and marijuana codes; and

**WHEREAS**, the bills relocating various provisions from Title 12 to Title 14, C.R.S. did not make substantive legal changes to the statutes for purposes of reference in the Parachute Municipal Code; and

**WHEREAS**, the references to Title 12, C.R.S. in the Parachute Municipal Code should be updated to reflect those provisions new location in Title 12, C.R.S. as made by the Title 12 Reorganization Bills; and

**WHEREAS**, the Town contracts with Code Publishing Co. for the maintenance of the Parachute Municipal Code; and

**WHEREAS**, Code Publishing Co. has offered to update references to Title 12 in the Parachute Municipal Code to reflect the recodification in Title 44; and

**WHEREAS**, the Town Council finds it is in the best interest of the Town to authorize Code Publishing to update references to Title 12, C.R.S. in the Parachute Municipal Code.

**NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO THAT:**


Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. The Parachute Municipal Code is hereby amended such that any references to statutory provisions affected by the Title 12 Reorganization Bills are amended to reflect the new statute location(s) as set forth in the Title 12 Reorganization Bills. Code Publishing Co. is hereby authorized to make such changes.




Public notice is hereby given that an Ordinance entitled:
