**ORDINANCE NO. 765-2019**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO, APPROVING A CONTRACT TO BUY AND SELL REAL ESTATE WITH JRP PROPERTIES, LLC AND TO AUTHORIZE SALE OF REAL PROPERTY LOCATED AT 220 1<sup>ST</sup> STREET AND 232 1<sup>ST</sup> STREET IN THE TOWN OF PARACHUTE**

**WHEREAS**, the Town of Parachute owns certain property located at 220 1<sup>st</sup> Street (Garfield County Parcel No. 240912113005) and 232 1<sup>st</sup> Street (Garfield County Parcel No. 24091211300), which are more particularly described in the Real Estate Contract referenced below (collectively, the “Property”);

**WHEREAS**, JRP Properties, LLC (“JRP”), a Colorado limited liability company, wishes to purchase, and the Town wishes to sell to JRP, the Property;

**WHEREAS**, accordingly, the Town and JRP have negotiated the Contract to Buy and Sell Real Estate (the “Real Estate Contract”) attached hereto as **Exhibit A**, which identifies the Property, purchase price, and other terms of sale;

**WHEREAS**, Section 1-18 of the Town Charter states that “[t]he [Town Council], by ordinance, may purchase, sell, exchange, receive by donation, and enter into a lease, or dispose of any interest in real property or water rights, including easements.”;

**WHEREAS**, further, Section 13-11 of the Town Charter states that “[t]he Town shall have the power to acquire, own, sell, lease, exchange, dispose of, or otherwise deal with real or personal property by ordinance without the need for an election.”;

**WHEREAS**, in evaluating the sale of the Property, the Town undertook a property valuation to ensure the Property is being sold at fair market value, which was included in the packet for the Town Council meeting;

**WHEREAS**, the Town Council believes it is in the best interests of the Town to sell the Property and advances a legitimate government interest; and

**WHEREAS**, the Town Council wishes to approve the Real Estate Contract, authorize the sale of the Property, authorize the Town Manager to make amendments to the Real Estate Contract, and take other acts reasonably necessary to sell and convey the Property, and authorize the Town Manager or Mayor to execute any documents to effectuate such conveyance, including a deed.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO THAT:**

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. The Town Council hereby approves the Real Estate Contract in substantially the same form as that enclosed as **Exhibit A**, incorporated herein by this reference and authorizes the Town Manager to make any amendments to the Real Estate Contract that are reasonably necessary for the sale of the Property without further approval of the Town Council.

Section 3. The Town Council hereby authorizes the Town Manager or Mayor to execute the Real Estate Contract, to take all actions pursuant to the Real Estate Contract, to sign all documents necessary to effectuate the sale and conveyance of the Property, including a deed and any documents required by a title company, and to take other actions related to this transaction.

Section 4. If any provision of this Ordinance is found to be unconstitutional or unlawful, such finding shall only invalidate that part of portion found to violate the law. All other provisions shall be deemed severable and shall continue in full force and effect.

**PUBLIC NOTICE**


Public notice is hereby given that an Ordinance entitled:
