

**TOWN OF PARACHUTE
ORDINANCE NO. 757-2019**

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO, CODIFYING THE RESULTS OF BALLOT QUESTION 2C SUCH THAT THE PARACHUTE MUNICIPAL HOME RULE CHARTER AND CODE REFER TO THE TOWN'S GOVERNING BODY AS "TOWN COUNCIL" INSTEAD OF "BOARD OF TRUSTEES".

WHEREAS, the Town of Parachute ("Parachute" or the "Town") is a home-rule municipality organized pursuant to Article XX of the Colorado Constitution and with the authority of the Parachute Home Rule Charter; and

WHEREAS, the Town was organized as a statutory town under the Colorado Revised Statutes, but has since adopted the Parachute Home Rule Charter to strengthen local self-governance; and

WHEREAS, by approving Ordinance Number 751-2018, the Parachute Board of Trustees put before the electors Question 2C, which asked:

SHALL SECTION 2-1 OF THE TOWN OF PARACHUTE HOME RULE CHARTER AND ALL OTHER CHARTER AND MUNICIPAL CODE SECTIONS REFERRING TO THE TOWN'S GOVERNING BODY AS THE BOARD OF TRUSTEES BE AMENDED TO INSTEAD REFER TO THE TOWN'S GOVERNING BODY AS THE TOWN OF PARACHUTE TOWN COUNCIL?

; and

WHEREAS, at the duly scheduled General Election held on November 6, 2018 the electors passed proposed Question 2C by a margin of 173 For and 114 Against; and

WHEREAS, on November 26, 2018, the Garfield County Clerk and Recorder certified said results, as shown on the certification attached hereto as **Exhibit A**; and

WHEREAS, the Town Council desires to carry out the will of the electors and amend the Parachute Home Rule Charter and Municipal Code to reflect the results of the General Election as it relates to Question 2C.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. The Parachute Home Rule Charter and Municipal Code are hereby amended such that any references to the Town's governing body as the "~~Board of Trustees~~" or "~~Board~~" instead

read "Town Council" or "Council".

INTRODUCED, READ, PASSED, ADOPTED, AND ORDERED PUBLISHED BY TITLE ONLY by a vote of 10 to 0 of the Town Council of the Town of Parachute, Colorado at a regular meeting held at Town Hall in the Town of Parachute, Colorado, on the 17th day of January 2019 and approved by the Mayor on the 17th day of January 2019.


