RESOLUTION NO. 2018-36

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH GARFIELD SCHOOL DISTRICT NO. 16, GARFIELD COUNTY BOARD OF COUNTY COMMISSIONERS, AND GARFIELD COUNTY SHERIFF'S OFFICE FOR THE PURPOSE OF PROVIDING AND MANAGING A SCHOOL RESOURCE OFFICER PROGRAM.

WHEREAS, GARFIELD SCHOOL DISTRICT No. 16 ("District"), the TOWN OF PARACHUTE, the GARFIELD COUNTY BOARD OF COUNTY COMMISSIONERS ("BOCC"), the GARFIELD COUNTY SHERIFF'S OFFICE ("Sheriff") wish to provide for a school resource officer at Grand Valley High School;

WHEREAS, to do so, the Parties wish to enter an agreement for the purpose of providing, managing a School Resource Officer Program, as set forth in **Exhibit A (the "SRO Agreement");**

WHEREAS, under the SRO Agreement, the Town is responsible for reimbursing the BOCC for thirty-three percent (33%) of SRO's annual salary and benefits package and such amounts are available under the Town's budget; and

WHEREAS, to provide for the safety, education, and protection of students at Grand Valley High School, the Board of Trustees wishes to approve the SRO Agreement and perform its obligations thereunder.

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF THE TOWN OF PARACHUTE, COLORADO THAT:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. The Board of Trustees hereby approves the SRO Agreement set forth in **Exhibit A**, authorizes the Mayor to sign the SRO Agreement, and authorizes Town staff to take such actions as necessary to perform under the SRO Agreement.

INTRODUCED, PASSED, APPROVED, AND ADOPTED by a vote of 6 - 0 of the Board of Trustees of the Town of Parachute, Colorado at a regular meeting held at Town Hall in the Town of Parachute, Colorado on the 16th day of August, 2018 and approved by the Mayor on the 16th day of August, 2018.
